

### 1. Safety instructions and measures

**A** DANGER

#### Danger due to suspended loads falling!

- → Stay clear of suspended or moving loads.
- → Close off and secure the transport paths.

## **A** WARNING

#### Risk of injury due to incorrect lifting without the use of lifting equipment!

Lifting the valve without the use of lifting equipment may lead to injuries (back injury in particular) depending on the weight of the valve.

→ Observe the occupational health and safety regulations valid in the country of use.

## **A** WARNING

#### Risk due to objects (components) falling down or out!

- → When mounting and dismantling, secure the components against falling down.
- → Secure the area.

## **A** WARNING

#### Risk of personal injury due to the valve tipping over!

- → Observe the valve's centre of gravity.
- → Secure the valve against tipping over or turning.

## **A** WARNING

#### Risk of lifting equipment tipping over and risk of damage to lifting accessories due to exceeding the rated lifting capacity!

→ Only use approved lifting equipment and accessories whose minimum lifting capacity is higher than the weight of the valve including actuator and packaging, if applicable.

#### Malfunction or risk of valve damage due to insufficient or incorrect support/suspension!

- → Observe the support points intended for this purpose.
- → Support the valve/actuator without stress or vibration.
- → If the pipeline is not self-supporting, the control valve and/or the pipeline must be supported or suspended.
- → Use sufficient and suitable supports or suspensions.

### 2. Dimensions and weights


The Type 72, 73, 82 Rotary Plug Valves are combined with the SAMSON VETEC Type MZ Pneumatic Actuators. The installation dimensions and supporting weights of the supplied valve can be found in the documents, e.g. dimensional drawings, delivery notes, etc.

The valve and actuator nameplates provide information on the design of the control valve (device).

### 3. Support and suspension conditions

The control valve with MZ actuator and, if necessary, the pipeline must be fitted with a suitable support or suspension.

To ensure that the control valve functions properly, make sure that the following conditions are met:

- → When supporting or suspending the actuator and/or the control valve in the pipeline, observe the specified support/suspension points.
- → Support/suspension should be vibration-free and without mechanical stresses.
- → First support the pipeline, then support the valve and actuator at the specified points.

#### 4. Support and suspension points · Control valve with actuator Type MZ

i Note

Selection and implementation of a suitable support or suspension of the installed control valve/actuator as well as the pipeline are the responsibility of the plant operator.

## • NOTICE

#### Risk of damage to the control valve due to incorrect attachment of the support/suspension!

The eyelets/eyebolts on actuator are only intended for supporting or suspending the actuator. They are not intended for supporting the entire control valve.


- → When supporting/suspending the control valve, make sure that the support/suspension attached to the valve body or to the bracket bear the entire load.
- → Do not attach the support/suspension for the entire control valve to the actuator, handwheel, accessories or other components.


### 4.1. Control valve with vertically upwards oriented actuator

SAMSON VETEC recommends installing the control valves so that the actuator is pointing vertically upwards. For the standard installation position of the control valve, see Fig. 2-2, 2-3 and 2-5.


#### Support/suspension points on the actuator and valve

### 4.2. Control valve with horizontally oriented actuator




